1 POINT PENALTIES

- A. Loss of working advantage
- C. Using corner or end of arena to turn cow
- E. Changing sides of the arena to turn cow
- L. For each horse length horse is ahead of cow
- P. Working out of position
- S. Stopping run

3 POINT PENALTIES

- K. Knocking down the cow without working advantage

5 POINT PENALTIES

- B. Spurring or hitting in front of cinch at any time or excessively whipping or spurring the horse
- C. Blatant disobedience defined as kicking, biting, bucking, rearing, striking or obviously insubordinate

0. SCORE - DISQUALIFIED

- A. Turn tail
- B. Lameness
- C. Using two hands on the reins in a bridle or two-rein
- D. Fingers between the reins in Romal Reins
- E. Extremely out of control
- F. Improper attire
- G. Illegal equipment
- H. Leaving working arena before run is complete
- I. Fall or horse or rider
- J. Schooling between cows if new cow is awarded

Note: Judge may blow the whistle at any time to terminate the work

Note: New Cow at Judge's discretion a rider will receive a new cow as necessary to show the horse. At the Judge's discretion
